

MEDICATION INFORMATION FOR NEW RESIDENTS IN ASSISTED LIVING AND SOUTHWOODS LODGE

If you or a member of your family is moving into Assisted Living or Southwoods Lodge level of care, here is some information regarding medications. According to California regulations, we are allowed to provide medication assistance to resident only after the medications have been authorized by the resident's physician(s).

1. All medications that the resident is taking must be medications authorized by his/her physician. This includes prescriptions, over-the-counter medications, and herbs and vitamins. This authorization must be done before the resident can receive any medication from our staff.

Please provide us with a list of all medications that the resident is taking so we can verify them with the resident's physician(s) **before** admission to Hillcrest.

2. The list of pharmacies that deliver to Hillcrest is on the next page. This could eliminate the need for you to have to go to the pharmacy to pick up the medications.

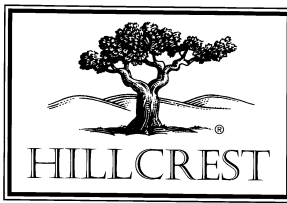
The California regulation states no medication can be given to a resident unless it has been authorized by the resident's physician(s). It is the policy of Hillcrest that any resident going into Assisted Living or Southwoods Lodge level of care will have their medications managed by the Resident Assistant. The Resident Assistant will assist the resident with self-administration of their medications. This does not mean that the Resident Assistant can force or camouflage the medication so the resident doesn't realize he/she is receiving medications. A record of medications and dosages will be maintained by Hillcrest and the medications will be centrally stored.

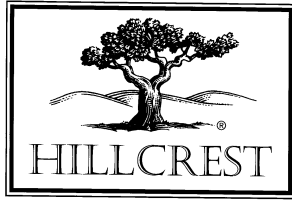
